Since the last Faculty Senate Meeting, the **following has been accomplished**: 1. Sheri Lazare and Cheylon Woods were elected by the faculty senate to serve on the Ways and Means Committee. Robert McKinney has proposed an addition to the Faculty Handbook (Document XXV) to establish a policy on granting emeritus status to retiring faculty. Ways and Means reviewed the policy and proposed the following amendments: 1. Delete the first sentence of the first paragraph under "Granting of Emeritus Titles". 2. To be added after the second sentence of the first paragraph under "Granting of Emeritus Titles" section: "The faculty senate, department head/director, or a Dean may recommend a nomination for Emeritus Status to the provost or President of the University." 3. Add a new section titled "Benefits of Emeritus Status" "Benefits of Emeritus status could include, but are not limited to, access to faculty parking, library services, recreational facility, reasonable office and lab space as needed, and all other benefits the university grants to retired faculty members. Emeritus faculty may serve as a PI or Co-PI on University grants under the same rules as other faculty per their College Dean approval. Emeritus faculty will be listed as such in the Faculty/Staff Directory. Emeritus faculty cannot be a voting member of the faculty senate." 3. 4. 5.
